Reconnect fees will apply when services are disconnected for non-payment. During business hours (8:00 am to 4:30pm) \$35.00 and after hours \$50.00. All amounts owed must be **paid in full at office**. No personal checks will be accepted at that time. Any account collected in the field will carry an additional charge of \$25.00

**CUSTOMER AGREEMENT / SERVICE CONTRACT ADDENDUM**

**\*\* By signing the application for water/wastewater services, the applicant agrees to pay a monthly rate / minimum charge as may be established by the Moncks Corner Water Works in accordance with its ordinances. The Moncks Corner Water Works has the right pursuant to the South Carolina Setoff Debt Collection Act to collect any sum due and owed by the applicant through offset of the applicant's state income tax refund. If Moncks Corner Water Works chooses to pursue debts owed by the applicant through the Setoff Debt Collection Act, the applicant agrees to pay all fees charged by the Department of Revenue, the Municipal Association of South Carolina and the Moncks Corner Water Works. If the Moncks Corner Water Works chooses to pursue debts in a manner other than the Setoff, the applicant agrees to pay the costs and fees associated with the selected manner as well. I understand that the service fee is non-refundable. I further understand that should I move I will be responsible for notifying the Moncks Corner Water Works promptly. Otherwise, I shall be responsible for further bills at the above address until notification. \*\*\* I UNDERSTAND THAT I WILL RECEIVE A FINAL BILL IF I DISCONNECT SERVICE AT ANY TIME AND WILL BE RESPONSIBLE TO PAY THE FINAL BILL IN FULL. I UNDERSTAND I MAY NOT RECEIVE MY FINAL BILL FOR THIS ACCOUNT UNTIL THE NEXT MONTH'S BILLING CYCLE DUE TO THE UTILITY BILLING SCHEDULE.**
